



- Measure Health & Safety Compliance and conduct audits on physical conditions and safe work practices.
- Stay up to date regarding legislation, regulations and standards affecting Health Safety & Environment.
- Ensure that all incident/ accident investigation information is accurate and completed in detail.
- Ensure that safety-related training records, accident reports and other documents are completed and stored properly.
- Maintain important information on boards, posters, safety signs on a regular basis.

- Coordinate safety training for employees and new employee orientation.
- Ensure all training documentation is completed and review training feedback.

- Advice on possible improvements actions in the field of the environment and sustainability.


